As part of your rights, you are entitled to a refund from your bank under the terms and conditions of your agreement with your bank. A refund must be claimed within 8 weeks of starting from the date on which your account was debited. Médecins Sans Frontières will send confirmation of your direct debt information no less than 7 days before your first direct debt is due to commence.
